Why should I come to this event?

The California Legislature will be considering numerous issues that could impact the staffing industry. Among the issues being considered are unemployment insurance tax increases, reforms in unemployment insurance eligibility, business tax increases, and legislation to further regulate health care staffing companies. It is important that your legislators hear from you firsthand how policy decisions they make affect your business and your ability to continue to stay in business and provide employment to their constituents. The annual legislative day has proven to be an effective tool in advancing the staffing industry's policy needs, while defending the industry from attack. Join your colleagues in this effort.

What is the fee to participate, and what is included?

How can I register to attend?

How can I find out who my legislator is?

It's very easy!! You can get current California legislative information by simply visiting this website: <http://www.leginfo.ca.gov/yourleg.html>. Once there, type in your residence zip code and you will get the name and contact information for your legislators.

How can I set up an appointment with my legislator?

The easiest way to schedule an appointment is to call the Capitol office at the Sacramento phone number of your legislators (see above) and ask to speak to the scheduler. Introduce yourself as a constituent who will be in Sacramento on March 23 for the *California Staffing Professionals Legislative*

Day and that you would like to meet with the legislator to introduce yourself, your industry, and discuss state issues of concern. **Your appointment should be made well in advance of March 23. Legislators' schedules fill quickly!** Many schedulers request that appointment requests be made in writing. These typically can be emailed or faxed and should be done right away.

If I want to spend the night, does CSP have a room block? Where can I stay?

We do have a block of rooms at the **Best Western Sutter House** for only **\$84** plus tax. This is the "state government rate" that the Sutter House has extended to our group! Simply tell the reservationist that you are with California Staffing Professionals. **The cut off date for discount reservations is Tuesday, March 16, 2010 (or when our block is filled). After this date the charge of regular corporate or rack rate of \$104.99-\$180.99 will apply.** The Sutter House is located at 1100 H Street, within walking distance of the State Capitol.
